

TERMS & CONDITIONS: Summers Offer Bouquet- 2018

1. DEFINITIONS:

Following words shall for the purpose of these terms and conditions, be defined to mean as below:

“**BFL**” refers to Bajaj Finance Limited.

“**Customer**” means an Indian citizen who avails a personal loan from BFL during the Offer Period.
